- 1. CHECKS must be payable by a US bank and must be free of any collection charges. Please mail to our PO Box address: Distribution-Publications, Inc., P.O. Box 1136, Oakland, CA 94604, USA. Please note, when you provide a check as payment, you authorize us to use info from your check to make a one-time electronic fund transfer from your account or to process the payment as a check transaction. When we use info from your check to make an electronic fund transfer, funds may be withdrawn from your account as soon as the same day we receive your payment, and you will not receive your check back from your bank. Also, when remitting payment on behalf of a third party, kindly provide the invoice numbers and/or account numbers to apply payment(s) against.

For members whose billing information are within the USA, please enter full credit card address on the billing address line and zip code exactly as required.

For members whose billing information are outside the USA, please enter full credit card address on the billing address line and zip code exactly as required. If state and/or zip code is not available, please enter NA.

Please note, if any required billing info is left blank, your online credit card transaction will be denied.

When your payment is submitted & approved, a transaction receipt will be sent directly to the email address you provided online.
