### IMPORTANT INFORMATION

- **Check-in Time** : Passenger to report 2 hours before departure. Check-in procedure and baggage drop will close 1 hour before departure.
- **DGCA passenger charter** : Please refer to passenger charter by clicking [Here](#)
- **Baggage information** : Carry no more than 1 check-in baggage and 1 hand baggage per passenger. Additional pieces of Baggage will be subject to additional charges per piece in addition to the excess baggage charges. Carry no more than 1 check-in baggage and 1 hand baggage per passenger. - **Check travel guidelines issued by Kerala below** : COVID test/ Vaccination rules: All travellers entering Kerala must either carry a final COVID vaccination certificate (15 days must have passed since final dose) OR a negative RT-PCR report with sample taken within 72 hours before arrival. 72 hour RT-PCR report is mandatory for travellers visiting for a short duration for purposes like business, official, trade, medical, court cases, property management etc. RT-PCR test timeline starts from the swab collection time. Travellers might not be allowed to board their flights if they are not carrying a valid test report/vaccination certificate. Thermal screening will be done for all travellers. Some travellers might have to undergo a self-paid RAT test upon arrival in Trivandrum. If the port of arrival is Kochi the RT-PCR testing facility is available at the airport. RAT test on arrival is at the discretion of the local health authorities. Quarantine rules: Travellers who do not want to undergo RT-PCR test upon arrival will be required to undergo mandatory 14 days home quarantine. Not applicable for travellers arriving into the city of Kannur. For Calicut only: Travellers undergoing test on arrival shall remain under home/institutional quarantine till the test result is declared. The transportation from airport to quarantine facility/home quarantine shall be in double chambered vehicles. Pre-registration and e-pass rules: Download and update the Aarogya Setu App. All travellers must register their details on Kerala's Jagratha portal and obtain an e-pass which should be shown to the health officials at the airport. For the complete list of travel guidelines issued by Indian States and UTs, if you have arrived on any international flight and are taking a connecting domestic flight, please check the 'Travelling to India' tab. Since guidelines are dynamic and might change regularly, we strongly recommend that you check the full text of the guidelines issued by the Government before travelling. travelling onward to Lakshwadeep, mandatory to have a negative COVID certificate obtained 48 hours before arrival to the island. Quarantine Guidelines : Mandatory home quarantine 14 days (except for short-term visitors staying less than 7 days). Destination Restrictions : None. Remember to web check-in before arriving at the airport; carry a printed or soft copy of the boarding pass. Please reach at least 2 hours prior to flight departure. The latest DGCA guidelines state that it is compulsory to wear a mask that covers the nose and mouth properly while at the airport and on the flight. Any lapse might result in de-boarding. Remember to download the baggage tag(s) and affix it on your bag(s).
