Cargo may not be loaded on the intended vessel and may be on forwarded to the port of destination on any

alternative vessel at Carrier's sole discretion. Furthermore in case of disruption of ports' operations, the cargo may be discharged in an alternative port without notice and - subject to availability - be on forwarded to the original intended port of destination. Carrier reserve its rights to accomplish the bill of lading in any alternative port. All additional costs, including but not limited to storage, demurrage, plugging, monitoring at the alternative discharge port or extra on forwarding costs, shall be on Merchant's account and payable before delivery and the carrier shall have no liability whatsoever for any loss or damage resulting thereof.
 - The Merchant warrants that the particulars relating to the Goods have been checked and that such particulars are adequate and correct. In case of failure of the Merchant to comply with such warranty, the Carrier shall be entitled to charge the Merchant at any time an amount of USD 2,000 per Container as processing and operational fees. This fee shall also be applicable in case of discrepancy between the Verified Gross Mass (VGM) sent to the Carrier and the weight declared by the Shipper in his shipping instruction or otherwise weighted during the Carriage.

RECEIVED from the Shipper in apparent good order and condition unless otherwise indicated, herein, the Goods, or the container(s) or package(s) said to contain the cargo herein mentioned, to be carried subject to all terms and conditions provided for on the face and back of this Bill of Lading, by the vessel named herein or by any additional or substitute vessel or means of transport chosen at the Carrier's option, from the place of receipt or the port of loading to the port of discharge or the place of delivery shown herein and there to be delivered. If required by the Carrier, this Bill of Lading duly endorsed must be surrendered in exchange for the Goods or delivery order. None of the terms of this Bill of Lading can be waived by or for the Carrier except by express waiver signed by a duly authorised agent of the Carrier.

THE CARRIER REMAINS HOWEVER AT LIBERTY TO BRING ANY CLAIM, ACTION OR PROCEEDING WHATSOEVER AGAINST THE MERCHANT BEFORE ANY OTHER COURT OF COMPETENT JURISDICTION.
