This agreement is made on 10<sup>th</sup> June 2022 between M/S.GOLDEN STAR COLD STORAGE CO,PLOT NO.1109/1110, G.I.D.C ESTATE VERAVAL-362269 GUJARAT, having their processing unit at veraval (herein after referred to as processor and which expression shall, unless repugnant to the context or meaning thereof mean and include its successors and assigns) of the ONE PART and

KMC MARINE EXPORTS Address: AMINA MENSION, NEAR MADINA MASJID SAHIGARA SOCIETY,VERAVAL, GUJARAT, GIR SOMNATH, GUJARAT, 362265 (herein after called the exporter which expression shall unless repugnant to the context or meaning thereof. Mean and include its successors or assigns) of the OTHER PART.

**NOW IT HEREBY AGREED BY AND BETWEEN THE PARTIES HRETO AS FOLLOWS;**

The exporter will provide required material to the processor from time to time for the purpose of processing and freezing as per the specifications/standard laid down by EIA. The processor will process raw material supplied by exporter as per the quality standard and specification as required for the purpose of export of fish & fishery products and will issue certificate of export worthiness to the exporter for the processed seafood consignment after charging the necessary monitoring / endorsement fee etc of EIA in advance.

The processor will maintain required freshness, quality and other specification that may be required by the exporter under the supervision of his representative. The processors will be paid agreed processing, freezing, storing and other charges by the exporter

TERMS AND CONDITIONS AS UNDER: -

1. The processing contract will be effective from 10<sup>th</sup> June 2022 to 09 June 2027 or more as agreed and accepted by both the parties.
2. The processor shall process for the exporter a minimum quantity of 1500 Tons of finished products during the period of one year.
3. The exporter shall supply Ice, Raw material, plastic. Carton and packing materials to the processors for processing and packing of F&FP.
4. All the other incidental expense other than those mentioned will be borne by the exporter at actual.
5. Any party wishing to terminate the agreement will have to give three months notice to the other and the jurisdiction of the agreement will be in veraval and on other place.
6. All payment with regards to EIA inspection fees, certificate charges and any other testing charges will be borne by the exporter.
7. All shipment & inspection expenses if any will be to the account of the exporter.
8. All payment to be made against delivery of inspection certificates / Health certificates issued by EIA against each shipment.
9. The exporter shall assure that the utilization of surplus capacity is as per MPEDA provisions & approval, He further agrees and understand that processor being the primary owner / manufacturer exporter will have the priority in decisions related to the working of the plant and utilizing the facility in most economic and efficient way.
10. Dedicated store will Be Allotted to store the processed and frozen material.
11. Processing or Bank Associated With the Processor will not claim any type of owner ship on the material processed and merchant Exporter can Hypothecate their stock with Bank and stock inspection can be carried out by bank officer with permission.

Furthermore, both the parties namely M/S.GOLDEN STAR COLD STORAGE CO. hereby affirm, agree to include/abide following three clauses in the agreement as well, as required by MPEDA, with their new guidelines inforce.

WHERE AS:

01.THE PROCESSOR POSSESSES A MARINE PRODUCTS PROCESSING PLANT AND HAS BEEN RUNNING THE BUSINESS PROCESSING OF MARINE PRODUCTS FOR EXPORTS PURPOSE

02.THE PROCESSOR AND THE EXPORTER HEREIN M/S.GOLDEN STAR COLD STORAGE CO. AND KMC MARINE EXPORTS. MANUALLY AGREED TO ENTER INTO A PROCESSING AGREEMENT FOR PROCESSING AND PACKING OF FROZEN MARINE PRODUCTS FOR EXPORT BY KMC MARINE EXPORTS FROM 10<sup>TH</sup> JUNE 2022 TO 09 JUNE 2027 NOW IN VIEW OF THE ABOVE THE PARTIES HAVE AGREED TO THE FOLLOWING TERMS AND CONDITIONS FOR THE PURPOSE OF CREATING A PROCESSING AGREEMENT IN FAVOR.

03.THE OWNER ON THE ONE HAND AND EXPORTER UTILIZING THE SUPPLUS CAPACITY ON THE OTHER SHALL ALSO BE RESPONSIBLE FOR ANY ACTS OF OMISSION & COMMISSION BY THE OTHER EITHER IN RESPECT OF TRADE RELATED ISSUE,INCLUDING CHEATING WHETHER OR NOT IT IS ATTRIBUTABLE TO PROBLEM REALTING TO THE PROCESSING PLANT OR HANDALING FACILITY

04.WE KMC MARINE EXPORTS ASSURE THAT WE SHALL ONLY UTILIZE THE SUPPLUS CAPACITY OF THE PROCESSING PLANT OR HANDALING CAPACITY OF THE PROCESSING PLANT OR HANDALING FACILITY,AS APPROVED BY MPEDA AND NOT ANY OTHER PROCESSING PLANT OR HANDALING FACILITY,
